Appeal from orders granting summary judgment, jury verdict and post-verdict orders in a matter involving a multi-party automobile accident. Issues include: 1) Ownership of salvage vehicles for purposes of insurance; 2) Whether multiple parties can be "owners" of a vehicle for insurance purposes; 3) Whether a towed vehicle was being "operated" at the time of accident; 4) Dismissal of negligence and nuisance claims against salvage dealer; 5) Sufficiency of service on foreign nationals; 6) Denial of motion to file amended complaint adding third-party insurer; 7) Evidentiary issues at trial; and 8) Denial of motion to make judgment enforceable against putative employer of driver.
