Horse racing case: Did the trial court err in dismissing Appellants' claims against Appellees that the wagers Appellants made using historic horse racing slot machines were illegal? The trial court held that Appellants were not able to recover the monies lost on these machines. The trial court held that KRS 372.005, which states that gambling transactions are not void as long as the gambling has been legalized or permitted, applied to preclude Appellants' recovery. The court also held that KRS 230.210, which defines pari-mutuel wagering, applied retroactively to the time when Appellants made their alleged illegal gambling bets. The court also held that KRS 367.220, the Kentucky Consumer Protection Act, could not allow for recovery because there was no evidence that Appellees were acting in a false or misleading manner. Finally, the court held that there was no unjust enrichment because Appellants entered into a proper gambling contract with Appellees.

Did the trial court make evidentiary and jury instruction errors that would necessitate vacating a jury verdict in favor of Appellee? Appellants argue that Appellee did not provide causation evidence that the hospital was the proximate cause of the patient's death and that the trial court should have granted summary judgment in their favor before trial began. Also, did the trial court violate the Kentucky "bare bones" jury instruction standard by giving a too detailed instruction to the jury? Further, did the trial court err in giving the jury a spoliation instruction? Also, did the trial court err in allowing Appellee to question witnesses about reports on changes made by the hospital after the death seemingly in violation of KRS 311.377, which prohibits such information from being introduced into evidence at trial. The court also allowed the jury to hear evidence of remedial policy changes made after the death of the patient.

This is a condemnation case arising out of the taking of (condemnation) approximately 18 acres of Wilkerson's farm for construction of a bypass road in Taylor County. The parties were unable to agree to a value of the property and the matter was submitted to a jury which awarded a fair market value far in excess of the value assessed and awarded by the Commonwealth. On appeal, the Commonwealth (Department of Transportation) first asserts that it was entitled to a directed verdict. In regard to the trial itself, there are several complaints. It is alleged that the trial court erred by refusing to strike the testimony of Wilkerson's expert witness and that the witness used the improper method valuation. It is alleged that the trial court erred by allowing testimony and argument regarding potential post-condemnation developments in the area. Finally, it is asserted that the trial court's instructions to the jury were erroneous.
