This is an appeal from a ruling by the Fayette Circuit Court, affirming a probate court ruling that denied amendment to a Revocable Trust by the original grantor, trustee and primary beneficiary. The courts below found that Appellant lacked the capacity to amend the Trust, based upon Orders of probate courts in both Michigan and Kentucky appointing a guardian/conservator for appellant. The court then also affirmed a sale of Trust assets negotiated by a successor trustee in the amount of \$18,000,000, which appellant contends is significantly undervalued. The trial court further found that appellant lacked standing to bring the appeal as he was not a party to the district court action.

These three appeals arise from a ruling of the Jefferson Circuit Court that certain provisions of House Bill 518 violate the Kentucky Constitution. House Bill 518, passed by the Legislature in 2021, made several changes to the composition of the Kentucky State Fair Board and the methods by which its members are selected. House Bill 518 also modified the structural governance of the Board, designating it as "an independent de jure municipal corporation." The Tourism Cabinet had previously overseen the Board's functions, budget and personnel. The trial court found that some portions were unconstitutional, and other clauses were in keeping with the Legislature's powers. These arguments require a review of the separation of powers doctrine, our Kentucky Constitution, and case law in interpreting those provisions and KRS 446.090 as to severability.
